Entries close day of trial for both Obedience and Rally Trials at 9:30 AM on Friday and 8:00 AM on Saturday and Sunday or when entry limits have been reached, at which time entries cannot be accepted, cancelled, altered or substituted except as provided for in UKC Dog Show Rules. **Judging begins at 10 AM on Friday. Judging begins at 8:30 AM on Saturday and Sunday.**

A fee of \$25.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. FAX'd entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

Awards and Prizes

Ribbons will be awarded for 1st through 4th placements in each titling class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score in each titling class. New titlists will receive a rosette. Rosettes and gifts will be awarded for each Obedience Trial for High in Trial, High Combined in Trial and High Scoring Junior Handler. UOCH, GOCH, UUDX, UROC, URX and UROG titlists will receive rosettes. Rosettes and a gift will be awarded for each Rally Obedience Trial for High in Trial and High Scoring Junior Handler.

Exhibitors free with entry. Public admission fee \$2.00 for 12 years and up, 11 and under admitted free. All spectator admission fees will be donated to a dog charity of 4RK9s choice.

From I-380 South

Exit 5^{th} Avenue SW, continue on to 3^{rd} St. SW to 1^{st} Avenue SW. Turn left on 1^{st} Avenue SW and stay in the left lane. Continue to 10^{th} St. SW, then turn left onto 10^{th} St. SW.

From I-380 North

Exit 1st Avenue W. Turn right onto 1st Avenue SW and get in the left lane. Continue to 10th St. SW and then turn left onto 10th St. SW.
