A fee of \$25.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

This is a tentative running order. It is subject to change or adjustment based on the actual number of entries received and/or weather conditions.

## **Trial Information**

If you do not pass the required PT test the club will refund you the full trial entry fees that were pre-paid. Refunds will be sent via mail within 10 days of the trial.

Crating space will not be available indoors and handlers will need to plan to work from vehicles.

No camping is available at the trial site and there is no room to park RVs or campers.

#### **Food**

Lunch will not be provided for competitors. Off-site luncheon options are available within a 10-20 minute drive from the trial site.

#### **Notice to Exhibitors**

"A" Section Classes - This section is open to all exhibitors and dogs that have not earned a title in the element in which they are entering or equivalent title in another organization. The exhibitor must own the dog entered or be a member of the owner's household or immediate family. Once the dog has earned the title they may no longer compete in the "A" section. No licensed or professional dog trainer or Nosework instructor, regardless of the person's status as an amateur or professional, may compete in this section. No person licensed to officiate Nosework in UKC or any other organization may compete in this section.

Exhibitors with more than one dog entered in a trial. Exhibitors may handle only one dog in each class, or element in each trial. An exhibitor may enter more than one dog in the same class or element so long as a separate handler is provided for each dog. Exhibitors may enter and handle more than one dog per trial provided the additional dog(s) are entered in a different class or element from all other entries being handled by that exhibitor.

A UKC registration number is required to participate in these trials. For information on UKC registration go to <a href="https://www.ukcdogs.com">www.ukcdogs.com</a>.

All dogs entered in the full trials at the Master level must have passed a Myrrh PT before running the Master searches for UKC to accept any passing results from the full trial Master level. All dogs entered in the full trials at the Elite level must have passed an Elite PT before running the Elite searches for UKC to accept any passing results from the full trial Elite level.

#### **Ribbons and Placements**

First, second, third and fourth place ribbons will be awarded only to dogs who qualify in all 4 searches in a Full Trial. Placements will be determined by combined fastest search times for a Full Trial. For dogs entered who are working on individual element legs and titles (not on the Full Trial "leg"), element title ribbons, including overall level title ribbons such as "Master Nosework", will be awarded.
