A fee of \$30.00 will be levied for a returned check. All entries must be submitted on Official UKC entry forms, one dog per entry form. Unsigned, incomplete, or illegible entries are not acceptable and will not be entered in the trial. Faxed entries and/or credit card payments cannot be accepted. Entries sent by overnight mail must

not require a signature. Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

This is a **tentative running order**. The running order is subject to adjustment or change based on the actual number of entries received and/or weather conditions.

To limit the number of people at the trial site, start times for the various element levels will be sent with final confirmation letters.

**Trial Information**

**Move-ups** will be allowed between trials. Move-ups for Saturday Trial 1 must be received by the trial secretary by Wednesday, May 20, 2026. Move-ups for Sunday must be turned into the trial secretary before you leave on Saturday.

Handlers need to plan to work from vehicles. Running vehicles in the parking lot will not be allowed.

Please remember to bring water, sunshades/screens, fans and items to keep you and your dog(s) cool. The parking area is not shaded. No camping or overnight stays at Trial Site.

**Food/Lunch** will **not** be provided for competitors. Cedar Rapids has multiple restaurants and fast-food options close to

the trial site. There is a convenience store across the street from 4RK9S.

### **Notice to Exhibitors**

**“A” Section Classes** - This section is open to all exhibitors and dogs that have not earned a title in the element in which they are entering or equivalent title in another organization. The exhibitor must own the dog entered or be a member of the owner’s household or immediate family. Once the dog has earned the title they may no longer compete in the “A” section. No licensed or professional dog trainer or Nosework instructor, regardless of the person’s status as an amateur or professional, may compete in this section. No person licensed to officiate Nosework in UKC or any other organization may compete in this section.

**Exhibitors with more than one dog entered in a trial** - Exhibitors may handle only one dog in each class, or element in each trial. An exhibitor may enter more than one dog in the same class or element so long as a separate handler is provided for each dog. Exhibitors may enter and handle more than one dog per trial provided the additional dog(s) are entered in a different class or element from all other entries being handled by that exhibitor.

### **Ribbons and Placements**

Placement ribbons will be provided for 1-4 placements in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score. New title ribbons will be offered for anyone earning a new element title. Rosettes also will be offered for those individuals completing their full level titles. Special Championship ribbons will also be available for level Champions and Grand Champion titles.

#### **Driving directions to Trial Site:**

**From I-380 South - Exit 5<sup>th</sup> Avenue SW**, continue on 3<sup>rd</sup> St. SW to 2<sup>nd</sup> Ave SW. Turn left onto 2<sup>nd</sup> Ave SW (one way) and stay in the right lane. Continue to 10<sup>th</sup> St SW then turn right onto 10<sup>th</sup> St SW. The building is on your right.

**From I-380 North – Exit 1st Ave W.** Turn right onto 1st Ave SW and get into the left lane. Continue to 10<sup>th</sup> St and turn left onto 10<sup>th</sup> Street SW. The drive to parking lot is ¾ block down on left.

Any exhibitor’s entries may be refused for previous misuse of the motel facilities.
